



CVC LDP1 Discharge 1 February - 30 April 2025







MC LDP1 - Surface Water Daily Discharge 1 February - 30 April 2025





CVC Depositional Dust (12 month rolling average)








MC Depositional Dust Monitoring

Dep Dust (12 mth rolling avg)








PM₁₀ Monitoring


PM10 (µg/m³) Monitoring (previous 12 months)








PM_{2.5} Monitoring




