Summary

Monitoring was undertaken in September 2016 with all results in compliance with the required limits.

Introduction

LakeCoal Pty Ltd (LakeCoal) operates the Mannering Colliery, an underground coal mine at the southern end of Lake Macquarie.

This monthly report is to satisfy the requirements of;

- section 66(6) of the Protection of the Environment Operations Act, 1997, to make monitoring data related to an Environment Protection Licence publically available and
- condition 7 & 10, schedule 5, of Development Approval 06_0311 (as modified) to provide details of monitoring results and environmental performance.

This report provides environmental monitoring data from Mannering Colliery for the period 1 September 2016 to 30 September 2016.

Environmental monitoring data is collected as required under Environment Protection Licence 191 (EPL 191).

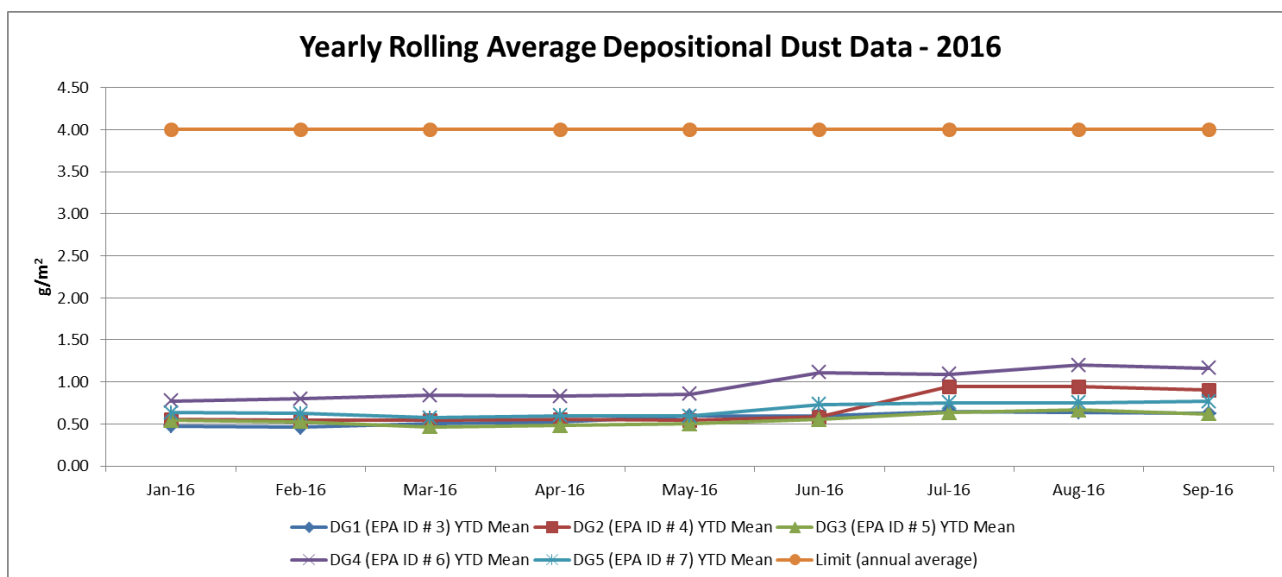
