Industry Update

discussed the following details with the members.

- Munmorah is to remain in Government ownership and decommissioning preparation continues;
- recent market price (high days in April);
- Vales Point operating efficiently and great availability;
- NSW spot price history, high prices due to plant not in service;
- high number wind generation in SA and the need for a reliable base line for supply; and
- SA is looking at interconnector options.

- Details regarding recent LTI;
- contractors are performing very well in safety;
- ongoing improvements in Risk Management;
- Power Industry Safety Games 2016, Delta came runners up in Fire Competition.
- blanket alcohol testing conducted in September; and
- stroke and diabetes assessment available for all employees

Production

- Both VP Units are in service.
- Unit 6 is scheduled for an outage in April 2017.
- VP Units are achieving great availability results.

Coal Supplies

• Chain Valley mine is planning a conveyor delivery option that is due to commence in 2017.

Trucks

- Biomass deliveries are still continuing.
- Vales Point Ash Dam capping limited to 30 trucks per day; actual movements are much less.

 - Replacement of four key feedwater heaters
 - Ash and Dust Pumping system augmentation
 - Wood pole 680 and 690 11kV transmission lines
 - Unit air compressor replacement

Vales Point Outage Projects

- Unit 5 Minor outage was completed in September. Works include;
 - 5A CEP and 5A ACW pumps replacements
 - BFPT HP/IP drains header valve installations
 - ACW pipework replacement
 - Superheater/reheater survey and repairs
 - o 5B FD fan bearing replacement
 - 5A BCP replacement
 - AVR modifications
 - Gen Tx inspections and repairs
 - Bunkering conveyor maintenance

Environmental Update

Community Enquiries

outlined the environmental and land management issues were raised in the last 3 months and confirmed that all community enquiries are investigated and appropriate responses and actions are provided. Also confirmed the Delta Community Incident Information number (1800 115 277).

Members were briefed on the Seagrass Monitoring Summer 2016 Report. Also the recent bushfire on Ruttleys Rd which occurred in October and the planned 2016/17 hazard reduction burns on Delta land.

went over the key facts for the Vales Point Solar project and explained at this stage the plan is at the preliminary investigation stage.

Several tree located in the ash dam were damaged in the 2013 bushfire. Unfortunately, due to heavy rain after the fire the trees did not recover.

Compliance

Members were advised **Example** that the power station is compliant for 2016/2017 first quarter. All environmental monitoring data is published on the company website monthly.
