1. Overview

- Proactively working with environmental regulators to ensure the best outcome is achieved for the business, environment and the community.
- Development and implementation of greenhouse gas and pollution reduction strategies.
- Continued scientific investigations to enhance knowledge of the environment.
- Efficient use of resources and elimination, minimisation, reuse, recycling or safe disposal of wastes.
