Industry and market update –

- Update on the generation industry, market trends and energy transition.
- Highlighted the ongoing need for network stability and reliability.
- Noted market uncertainty and Federal election in May, with potential for policy change.
- Shared insight into Delta's plans and role in supporting the transition.

Vales Point Battery Energy Storage System (BESS) update –

- Project in feasibility and scoping phase. Various preliminary technical, social, and environmental assessments underway.
- Scoping Report and Request for Secretary's Environmental Assessment Requirements (SEARS) being prepared for Department of Planning, Housing, and Infrastructure (DPHI) – first step in State Significant Development Application (SSDA) process.
- Umwelt Environmental and Social Consultations engaged to prepare the Scoping Report and SEARS. Umwelt will present update to group on the social impact scoping assessment.
- Early community consultation conducted in April to understand early views on project, how best to
 engage with community and potential project impacts for investigation in the next phase of project.
 Included letterbox drop to closest neighbours, project webpage with online survey link and
 discussions with key stakeholders and community representatives.
- Feedback received is shaping the Community and Stakeholder Engagement Strategy for the next phase, which will include consultation with wider community later this year.
- Key program activities to end 2025 include conducting technical and environmental investigations, consulting and seeking feedback from wider community and stakeholders, and preparing the SSDA which is expected to be lodged by end of 2025.

Vales Point BESS Social Impact Assessment Scoping - Umwelt

Presentation of preliminary findings and associated community engagement.

Operations and assets update –

Generation:

- Unit 5 is in service. YTD availability 79.29%
- Unit 6 is in service. YTD availability 84.23%
- VP5 minor outage planned for October work scope and preparations shared.

Coal supplies and truck movements:

- Chain Valley mine deliveries via conveyor.
- Train supplies from Centennial Airly and Glencore Mt Owen.
- Minor volume from Port of Newcastle via trucks.
- Biomass deliveries via truck are continuing.
- Vales Point Ash Dam deliveries vary due to the weather.

Health, safety and environment update –

Safety and health:

- 83 days since last LTI (Delta) and 189 days since last LTI (Contractors)
- Routine respiratory health care screening for Vales Point employees in April 2025 via iCare Dust Disease Care (DDC) Mobile Health Screening Clinic.

Environment:

- Overview of community enquiries received and investigated in last 3 months.
- Update on Vales Point Power Station Management Weed Management Pan works being completed in accordance with plan and identified priority areas.
- Update on emissions and air quality reporting. Data available on Delta's website.
